PROCESS OF MAKING

For making effective NAP-CIDM the drafting of NAP-CIDM was done under the Chairmanship of Member (Chemical Disaster Management) NDMA with due consent of MoEF and DMI.

The process started with constitution of a core group (Annexure-2.1) in a meeting at NDMA with the national experts. Chairman of Core Group communicated the ToRs of the NAP-CIDM to the following target groups for input:-

- i) Regulators (both states and national);
- ii) Concerned ministries (both state and national);
- iii) Industrial Associations;
- iv) Industries, etc.

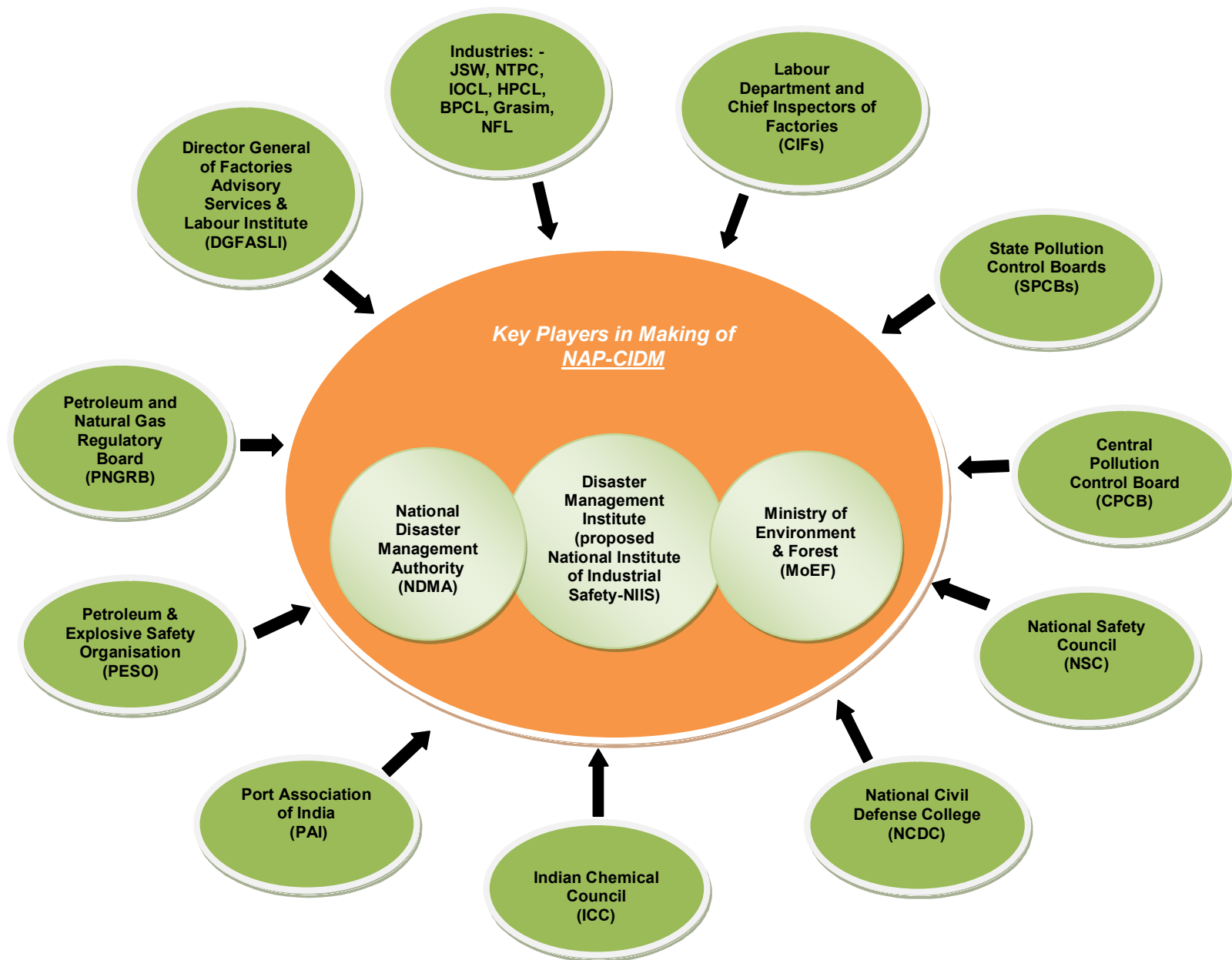


Fig. 2.1: Important Stakeholders of NAP-CIDM

All important stakeholders are shown in Fig. 2.1.

The ToRs were discussed in details with identified target groups in the seven meetings at Delhi and Bhopal to get their observations, comments and suggestions for NAP-CIDM.

The last meeting was held in Bhopal on Dec 06, 2011 under the chairmanship of Shri M. Shashidhar Reddy, Honorable Vice Chairman, Dr. Muzaffar Ahmed, Honorable Member, NDMA; Dr. Chhanda Chowdhury, Director, MoEF and with other stakeholders for finalisation of draft NAP-CIDM. It was agreed in principle to finalise it in next few months after getting suggestions from various stakeholders.

The overall summary of various steps adopted in the process of making NAP-CIDM is shown in Exhibit 2.1.
